MUNICIPAL ORDINANCE NO. 2021-04 Series of 2021

AN ORDINANCE AMENDING BY DELETION SECTION 3.2.a.3., SECTION 3.2.b., SECTION 4.I.C, SECTION 4.II, SECTION 5.b. AND AMENDING BY CHANGING SECTIONS 4.I.A.2., 4.I.B.3, AND 4.III.1 OF MUNICIPAL ORDINANCE NO. 17-003, SERIES OF 2017 ALSO KNOWN AS THE "NEW PUBLIC CEMETERY ORDINANCE OF THE MUNICIPALITY OF PIÑAN, ZAMBOANGA DEL NORTE"

Be it ordained by the Sangguniang Bayan of Pinan, Zamboanga del Norte in session duly assembled that:

SECTION 1. Title – This ordinance shall be entitled as "An Ordinance Amending by Deletion Section 3.2.a.3., Section 3.2.b, Section 4.I.C, Section 4.II, Section 5.b and Amending by Changing Sections 4.I.A.2., 4.III.1 Municipal Ordinance No. 17-003, Series of 2017 also known as the New Public Cemetery Ordinance of the Municipality of Piñan, Zamboanga del Norte".

SECTION 2. – The amendments are hereby reflected hereunder as follows:

" SECTION 3. GENERAL PROVISIONS.

- 1. It shall be unlawful for any persons to bury human remains in places other than those legally authorized in conformity with the provisions of P.D. No. 856, otherwise known as the Code of Sanitation.
 - 2. Grave area shall be in the form of:
 - a. Apartment Type (Niche)- located at the borders, serving as perimeter fence of the new cemetery and shall consist of five levels/decks which classified as follows:
 - a.1. Niches for Cadaver (Fresh Burial)
 - a.2. Niches for Skeletal Remains
 - a.3. deleted
 - b. Deleted
 - c. Mausoleum- this is a burial space with a measurement per lot of 3x3 m.

SECTION 4. GUIDELINES AND FEES. The following guidelines and fees shall be observed by any applicant who wishes to have its remains buried in the Piñan Memorial Park.

- I. Apartment Type (Niche)
- A. Niche for Cadaver (Fresh Burial)

- 2. A lease fee of P 10,000.00 shall be collected by the Municipal Treasurer's Office as monetary consideration for the niche construction and execution of lease contract for fifteen (15) years plus P 100.00 annual fee upon application as maintenance fee.

- B. Niches for Skeletal Remains:

- 3. In case the family members of the dead, whose contract of lease has expired after fifteen (15) years, do not initiate transfer of remains, the LGU shall automatically cause its transfer to the common skeletal remain grave.

- 1. A fee in the amount of P 30,000.00 per unit shall be paid at the Office of the Municipal Treasurer excluding burial fees as provided for under existing Revenue Code of Piñan, Zamboanga del Norte.
