MUNICIPAL ORDINANCE NO. 2021- 05

Series of 2021

AN ORDINANCE DESIGNATING PARKING AREAS FOR MOTOR VEHICLES AND MOTORCYCLES WITHIN THE POBLACION AREAS OF THE MUNICIPALITY OF PIÑAN, ZAMBOANGA DEL NORTE AND PROVIDING FEES THEREOF AND FOR OTHER PURPOSES

Be it ordained by the Sangguniang Bayan of Pinan, Zamboanga del Norte in session duly assembled that:

SECTION 1. TITLE– This Municipal Ordinance shall be entitled an "An Ordinance Designating Parking Areas for Motor Vehicles and Motorcycles within the Poblacion Areas of the Municipality of Piñan, Zamboanga del Norte and Providing Fees Thereof and for Other Purposes".

SECTION 2. SCOPE AND OBJECTIVES. This ordinance supplements the existing traffic ordinances of this municipality. It also applies to the motor vehicle and motorcycle owners and drivers within the territorial jurisdiction of this municipality. It has the objective of providing parking areas to ensure orderly flow of traffic and organized parking areas, regulating the traffic situation and road conditions within its jurisdiction, and eradicating congestion and other vehicular accidents.

SECTION 3. PARKING AREAS- the following are the spaces determined as parking areas:

- A. For motorcycles, the parking areas will be the following:
 - a) Areas in front of Lim's Bodega; and
 - b) A portion of Piñan Bus Terminal
- B. One-side parking for motorcycles is hereby declared on the following streets:
 - a) Amaga Street Extension- left side coming from National Highway
 - b) San Nicolas Street- left side coming from the National Highway

Provided however, that driveways along the authorized parking lane shall be maintained free of obstruction.

- C) For motor vehicles, the following spaces provided for parking areas are as follows:
 - a) Open Parking Area Site along San Nicolas Street; and
 - b) Open Space in front of Building III and PiMPCo Office

SECTION 4. LOSS AND DAMAGES ON PARKED MOTORCYCLES AND VEHICLES. The Municipal Government of Piñan shall not be held accountable for any loss of article(s) inside or outside a vehicle and/or damages thereof, regardless of amount or nature, while the vehicle is park at the parking area.

SECTION 5. PARKING TIME. The schedule of parking shall be as follows:

Monday to Sunday - 6:00 Am to 6:00 PM

SECTION 6. PARKING FEES. This parking fee covers the motorcycles or single motorcycles and motor vehicles as provided in this Ordinance.

•	Motorcycle or Single Motorcycle	P 5.00/day
•	Motor Vehicle (Private Cars and Service Vehicle)	P 5.00/trip

SECTION 7. PARKING FEE ON REGULATED PARKING AREA. Parking Fees will only be applied on the following areas as provided under Section 3 of this Ordinance. The following are:

- a) A portion of Piñan Bus Terminal;
- c) Along San Nicolas Street for motor vehicle; and
- d) In front of Building III and PiMPCo Office.

SECTION 8. EXEMPTION/DISCOUNT/ PRIVILEGE- The imposition of parking fee mandated by this ordinance and existing ordinances as provided under Municipal Ordinance No. 18-008, Series of 2018 otherwise known as the Revised Revenue Code shall be subject to exemption/discount/privilege as set forth below:

- a.) Local Government Officials and Employees may avail of the parking space free of charge during working hours; and
- b.) Discount of 20% to Senior Citizens and PWDs.

SECTION 9. COLLECTION-IN-CHARGE. The Municipal Treasurer or his or her authorized representative is hereby empowered to collect herein parking fees using any

- a.) Local Government Officials and Employees may avail of the parking space free of charge during working hours; and
- b.) Discount of 20% to Senior Citizens and PWDs.

SECTION 9. COLLECTION-IN-CHARGE. The Municipal Treasurer or his or her authorized representative is hereby empowered to collect herein parking fees using any form of official receipt he may devise from the conductor, driver, operator and/or owner of the motor vehicles parked in said designated parking areas and the motor shall be recorded on a separate subsidiary ledger. On the other hand, any designated personnel by the Local Chief Executive may be allowed to collect parking fees.

SECTION 10. PENAL PROVISION. Any person or persons, violating any provision of this ordinance shall be meted with the following:

1st Offense - Fine of Two Hundred Pesos (P 200.00);

2nd Offense - Fine of Three Hundred Pesos (P 300.00);

3rd and Succeeding Offenses- Fine of Six Hundred Pesos (P 600.00) or imprisonment of three (3) months or both at the discretion of the court.

SECTION 11. SEPARABILITY CLAUSE – If, for any reason, this Ordinance or parts hereof be declared unconstitutional or invalid by a component court, other parts or provisions thereof not affected shall remain in full force and effect.

SECTION 12. REPEALING CLAUSE – All Ordinances, issuances, rules and regulations inconsistent with the provisions of this ordinances are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY CLAUSE – This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
