MUNICIPAL ORDINANCE NO. 2021-013

AN ORDINANCE GRANTING 50% DISCOUNT ON THE NEW MONTHLY RENTAL PAYMENT TO ALL STALLHOLDERS OCCUPYING STALL/BLOCK OWNED BY THE LOCAL GOVERNMENT UNIT AT PIÑAN PUBLIC MARKET IN THIS MUNICIPALITY DURING THE PERIOD OF MODIFIED ENHANCED COMMUNITY QUARANTINE

WHEREAS, international, national and local health and governmental authorities are responding to an outbreak of respiratory disease caused by a novel coronavirus named "Corona Virus Disease 2019", abbreviated as (CoViD-19);

WHEREAS, Presidential Proclamation No. 922 dated March 9, 2020 was issued by the President of the Republic of the Philippines declaring a State of Public Health Emergency throughout the country and enjoining all local government units to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the CoViD-19 threat;

WHEREAS, on March 16, 2020, the State of Calamity was declared by the President pursuant to Proclamation No. 929 that affords LGUs ample latitude to utilize

appropriate funds in response to disaster preparedness and response efforts to contain the spread of the deadly virus;

WHEREAS, the Province of Zamboanga del Norte through the Provincial Governor issued an Executive Order declaring the whole Province under the Modified Enhanced Community Quarantine for the month of June and mid-July this year per recommendation from the National IATF-EID wherein a lot of restrictions and limitations are being imposed more specifically on those affected non-essential businesses operations;

WHEREAS, Municipality of Piñan adopted the declaration of Modified Enhanced Community Quarantine and some non-essential establishments are temporarily closed, due to that effect, business owners may have experienced a sudden and unexpected loss of income that would unable them to pay to the government their monthly rental dues and other obligations;

WHEREAS, in the interest of public welfare, as affected by the emergency caused by the spread of CoViD-19, it is necessary for the Sangguniang Bayan Council to enact this Ordinance for the protection of life and property;

NOW, THEREFORE, the Sangguniang Bayan Council of this Municipality of Piñan hereby enacts as follows:

Section 1. Title. This Ordinance shall be entitled "*An Ordinance Granting 50% Discount on the New Monthly Rental Payment to all Stallholders occupying stall/block owned by the Local Government Unit at Pinan Public Market in this Municipality during the period of Modified Enhanced Community Quarantine*".

Section 2. Rules and Regulations.

Pursuant to Article I. Market Fees and Charges of Municipal Ordinance No. 18-008, Series of 2018, "*An Ordinance Revising the Revenue Code of the Municipality of Piñan, Zamboanga del Norte*" as amended pursuant to Municipal Ordinance No. 2021-03, Series of 2021 provides the new fees and charges of the stalls/blocks in the Piñan Public Market.

Due to the emergency cases caused by the CoViD-19 pandemic, the Local Government Unit of Piñan through this Honorable Council intended to provide rules and regulations, as follows:

1. The Office of the Municipal Treasurer through the Market Administrator shall cause the inventory of those offering essential and non-essential services occupying the rental spaces owned by the Local Government Unit of Piñan.
2. Stalls offering essential and non-essential services shall be granted at 50% discount block/stall rental starting June, 2020 to July, 2021, subject for extension depending on the situation and other local issuances.
3. The list of business establishments or stall owners availed the rental payment discount shall be kept in the Office of the Municipal Treasurer and furnish the Office of the Municipal Mayor and Office of the Sangguniang Bayan for verification and information.

Section 3. Repealing Clause. All ordinances, rules and regulations, or part thereof, in conflict with, or inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity. This Municipal Ordinance shall take effect after posting within ten (10) days in three (3) conspicuous places in this municipality.
