MUNICIPAL ORDINANCE NO. 2021-015

AN ORDINANCE TEMPORARILY SUSPENDING THE COLLECTION OF FEES AND CHARGES IMPOSED UNDER SECTION 4.I.A.2. OF MUNICIPAL ORDINANCE NO. 2021-04, SERIES OF 2021, THEREBY PROVIDING FREE BURIAL AND RELATED SERVICES TO ALL INDIGENT BONA FIDE RESIDENTS OF PIÑAN, ZAMBOANGA DEL NORTE WHO DIED DUE TO COVID-19 RELATED DEATH EITHER CONFIRMED, SUSPECT OR PROBABLE COVERING THE PERIOD WHEREBY THE STATE OF CALAMITY IS IN EFFECT

WHEREAS, Article II, Section 15 of the 1987 Constitution, which declares that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the State recognizes public health emergencies, including pandemics, as threats to public health and national security, which can undermine the social, economic and political functions of the State;

WHEREAS, Section 16 of Republic Act No. 7160, the Local Government Unit of Piñan may exercise powers expressly granted, those necessarily derived therefrom, as well as power necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare within its territory, which includes the promotion of health and safety, the maintenance of peace and order, and the preservation of the comfort and convenience of their inhabitants;

WHEREAS, on March 11, 2020 , due to the widespread cases and increased risk of spread of COVID-19 throughout the globe, the World Health Organization (WHO) declared COVID-19 as a pandemic;

WHEREAS, pursuant to Presidential Proclamation No. 1218 dated September 10, 2021 further extended the State of Calamity effective September 13, 2021 to September 12, 2022;

WHEREAS, due to the COVID-19 surge, casualties from this locality are expected, in fact, for the past months, a number of Piñanons were buried outright in compliance to the handling of the dead protocol;

WHEREAS, in this pandemic, hardships are being experienced by the people of Piñan, the added financial burden of paying for urgent burial services must be dispensed with to hasten the disposal of the remains of the deceased and to further protect the constituents from COVID-19 and other deadly diseases;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN, IN SESSION DULY ASSEMBLED:

Section 1. Title- An Ordinance Temporarily Suspending the Collection of Fees and Charges imposed under Section 4.I.A.2. of Municipal Ordinance No. 2021-04, Series of 2021, thereby providing free burial and related services to all indigent bona fide residents of Piñan, Zamboanga del Norte who died due to COVID-19 related death either confirmed, suspect or probable covering the period whereby the State of Calamity is in effect.

Section 2. Explanatory Provision. Due to the COVID-19 pandemic, it is the intention of the Local Government Unit of Piñan through this Honorable Council to lessen the burden of the family whose death of family members was inflicted with COVID-19 either confirmed, suspect or probable.

Section 3. Applicability and Coverage. The suspension of fees and charges for the niches at the Piñan Memorial Park will apply to all indigent residents of Piñan whose death is inflicted with COVID-19 which can either be confirmed, suspect or probable.

In addition, the suspension of fees and charges shall cover while the State of Calamity due to COVID-19 is in effect.

Section 4. Suspension of Fees and Charges. The fees and charges as provided under Section 4.1.A.2. of Municipal Ordinance No. 2021-04 as hereunder stated is hereby temporarily suspended.

"Section 4.1.A.2. A lease fee of P 10,000.00 shall be collected by the Municipal Treasurer's Office as monetary consideration for the niche construction and execution of lease of contract for fifteen (15) years plus P 100.00 annual fee upon application as maintenance fee."

Section 5. Effectivity. This Municipal Ordinance shall take effect upon its approval by the reviewing authority.

RESOLVED, as it is hereby resolved, to approve the recommendation of this Body's Committee on Ways and Means, as contained in Report No. WM- 21-06, which was submitted on November 8, 2021, thereby **declaring in order and operative** Municipal Ordinance No. 2021-015, series of 2021 of the Sangguniang Bayan of Piñan, Zamboanga del Norte, entitled: "An Ordinance Temporarily Suspending the Collection of Fees and Charges Imposed Under Prescribing Section 4.I.A.2 of Municipal Ordinance No. 2021-04, Series of 2021, Thereby Providing Free Burial and Related Services to All Indigent Bona Fide Residents of Piñan, Zamboanga del Norte Who Died Due to Covid-19 Related Death Either Confirmed, Suspect or Probable Covering the Period Whereby the State of Calamity is in Effect", there being no apparent legal impediment for its passage and it being well within the ambit of the power of the local government unit to create its own sources of revenue and to levy taxes, fees and charges subject to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and the same is found substantially in order.
