MUNICIPAL ORDINANCE NO. 2024-004 Series of 2024

AN ORDINANCE AMENDING SECTION 3, PARAGRAPH A (2) AND DELETING SECTION 4 PARAGRAPH 2 (B) AND (C) OF MUNICIPAL ORDINANCE NO. 16-008, SERIES OF 2016

Be it enacted by the Sangguniang Bayan of Pi**ň**an, Zamboanga del Norte in a session duly assembled, that:

SECTION 1. TITLE- An Ordinance Amending Section 3, Paragraph a (2) and deleting Section 4, paragraph 2 (b) and (c) of Municipal Ordinance No. 16-008, Series of 2016.

SECTION 2. PURPOSE- The purpose of this Ordinance is to utilize the newly constructed road expansion on certain areas which are declared one way and to regulate the traffic by diverting to other routes conveniently accessible to the general public.

SECTION 3. AMENDMENTS- The following provisions to be amended as reflected in Municipal Ordinance No. 16-008, Series of 2016 are:

- 3.1. Section 3, Paragraph A (2)-
- 2. All PUBs, PUJs, and all other passenger buses emerging from Aseniero, Dapitan City shall turn left passing Macapagal Street, then turn right proceeding to Piňan Bus Terminal.

As hereby amended as follows:

Section 3, Paragraph A (2)-

- 2. All PUBs, PUJs, and all other passenger buses emerging from Aseniero, Dapitan City shall urn left passing Quirino Street, then turn left proceeding to Piňan Bus Terminal (front area).
 - 3.2. Section 4 -One Way Streets
- (2) The following streets, highways or portions thereof are hereby designated as one way streets with its corresponding direction:
 - a) Magsaysay Street; (exit)
 - b) Mabini Street; (entrance)
 - c) Anacleto Carreon Street; (exit)
 - d) Amaga Street Extension; (entrance)
 - e) General Malvar Street; (exit) and
 - f) San Nicolas Street (entrance).

As hereby amended as follows:

- 3.2. Section 4 -One Way Streets
- (2) The following streets, highways or portions thereof are hereby designated as one way streets with its corresponding direction:
 - a) Magsaysay Street; (exit)
 - b) Amaga Street Extension; (entrance)
 - c) General Malvar Street; (exit) and
 - d) San Nicolas Street (entrance).

SECTION 4. EFFECTIVITY- The said Ordinance is effective immediately after approval.
