# **MUNICIPAL ORDINANCE NO. 2024-010**

Series of 2024

AN ORDINANCE FOR THE TEMPORARY CLOSURE OF ANACLETO CARREON STREET, PORTION OF MAGSAYSAY STREET AND ALL OTHER STREETS SURROUNDING THE UBAY TRIANGLE FOR THE CONDUCT OF ACTIVITIES RELATED TO TOURISM AND FIESTA CELEBRATION IN THE MUNICIPALITY OF PIÑAN, ZAMBOANGA DEL NORTE

Be it enacted by the Sangguniang Bayan of Piñan, Zamboanga del Norte in a session duly assembled, that:

**Section 1. Title-** This Municipal Ordinance shall be entitled "An Ordinance for the Temporary Closure of Anacleto Carreon Street, Portion of Magsaysay Street and all other streets surrounding the Ubay Triangle for the conduct of activities related to tourism and fiesta celebration in the Municipality of Piňan, Zamboanga del Norte.

**Section 2. Authority and Purpose**. Pursuant to Article 43, Rule VIII of the Implementing Rules and Regulations of the Local Government Code of 1991, a local government unit through an ordinance may temporarily close any road, alley, park or square within its jurisdiction. Likewise, Article 45 of the same Code also states that "any road may be temporarily closed during actual emergency or fiesta celebration, public

rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications and waterworks projects for the period as may be determined to be necessary and reasonable".

In celebration of Tourism Month and Fiesta Celebration, various agricultural and social activities are conducted.

**Section 3. Duration.** The temporary closure will take effect on August 18, 2024 to August 22, 2024.

**Section 4. Effectivity.** This Municipal Ordinance will be approved after posting in three (3) conspicuous places in this Municipality.
