**AN ORDINANCE FOR THE ESTABLISHMENT OF PUBLIC LIBRARY AND
CENTER FOR E-LEARNING OF PIÑAN, ZAMBOANGA DEL NORTE
APPROPRIATING THE NECESSARY FUNDS THEREFORE AND OTHER
PURPOSES**

Sponsored by: Honorable Benedicto C. Cainta II

Be it enacted by the Sangguniang Bayan of Piñan, Zamboanga del Norte, in a session duly assembled:

SECTION 1. TITLE. This ordinance shall be known as the “*The Establishment of Public Library and Center for E- Learning of Piñan, Zamboanga del Norte, Appropriating the Necessary Funds Therefore and Other Purposes*”.

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the Municipal Government of Piñan, Zamboanga del Norte to increase the literacy rate and emphasize the significant role of education in nation-building through the establishment of public library and center for e-learning.

SECTION 3. OBJECTIVE. This Ordinance aims to provide all resident students of Piñan, Zamboanga del Norte free educational resources. This will promote the moral and intellectual well-being and increase the literacy rate of the youth of Piñan.

SECTION 4. DEFINITION OF TERMS. For the purpose of this Ordinance, the following terms shall be understood to mean as:

- a) **Public Library** – is a library that is accessible by the general public and usually funded from the public sources, such as taxes. Its shall be operated by the Municipal Government of Piñan, Zamboanga del Norte.
- b) **Resident Students** – a person who is studying at any schools, centers, college or universities that resides in Piñan, Zamboanga del Norte.
- c) **Computer** – an electronic device for storing and processing data, typically in binary form, according to instructions given to in a variable program.
- d) **Wi-Fi** – a facility allowing computers, smartphones, or other devices to connect to the internet or communicate with one another wirelessly within a particular area.
- e) **Textbooks** – a book used as a standard work for the study of a particular subject.
- f) **Archives** – refer to public records, papers, periodicals, books or other items, articles or materials, whether in the form of electronic, audio-visual or print, which by their nature and characteristics have enduring value, that have been selected for permanent preservation.
- g) **Public Records** – refer to records or classes of records, in any form, in whole or in part, created or received by a government agency in the conduct of its affairs, and have been retained by that government agency or its successors as evidence or because of the information contained therein.
- h) **Librarian** – refers to a person that deals with the library’s functions, which shall include, but not limited to the following: 1) Selection and acquisition of multi-media sources of information which would best respond to clientele’s need for adequate, relevant and timely information; 2) Cataloguing and Classification of knowledge or sources of information into relevant organized collections and creation of local databases for speedy access, retrieval of delivery of information; 3) Development of computer assisted/computer-backed up information systems which would permit online and network services; 4) Establishment of library system and procedures; dissemination of information; rendering of information, reference and research assistance archiving; and education of users; 5) Organization, conservation, preservation and restoration of historical and cultural documents and other intellectual properties.
- i) **Municipal Library Board** – the one who will promulgate rules and regulations regarding all matters of the public library.
- j) **Center for E-Learning** – A place in which skill-specific sets of activities are developed for student to work on independently at their own pace. It provides electronic learning and integrated set of interactive online services for trainers, learners and others involved in education.

SECTION 5. COMPOSITION. The Municipal Library Board shall be composed of the following;

- Chairperson : Municipal Mayor
- Vice-Chair : Chairman, Committee on Education
- Members : Vice Mayor
Members of SB Committee on Education

Chairperson of SB Committee on Tourism, Arts and Cultural Affairs
SK Federation President
Municipal School District Supervisor
Head of the Human Resource Management Office
Representative of the Student Leaders Organization

SECTION 6. POWERS AND FUNCTIONS. The Municipal Library Board shall have the following powers and functions:

- a) To promulgate and determine policies for the effective and efficient operation and maintenance of the Piñan, Zamboanga del Norte Public Library;
- b) To serve as an advisory committee to the Sangguniang Bayan on Library matters, such as but not limited to the necessity for the application of local appropriations for public library purposes;
- c) To find ways and means in increasing the book and non-book collections of the Piñan, Zamboanga del Norte Public Library and in improving the facilities of the library;
- d) To provide recommendations and suggestions on the selection of library materials, library rules and regulations and other library problems;
- e) To promote and strengthen partnership between the library and the community; and
- f) To ensure that the students have access to a wide variety of up-to-date learning materials.

SECTION 7. APPROPRIATION. In the next ensuing fiscal year after this Ordinance shall have become effective, the Sangguniang Bayan shall cause the appropriation of funds necessary for the Municipal Public Library and Center for e-Learning to efficiently and effectively carry out the provisions of this Ordinance, and to include therein all necessary operational or program support expenditures. The amount necessary to carry out provisions of this Ordinance embodying annual or supplemental budget and, every year thereafter, the same shall be included in the annual budget of the Municipal Mayor.

SECTION 8. SUPPLEMENTARY CLAUSE. The provisions of R.A. 7743, otherwise known as "*An Act Providing for the Establishment of Congressional City, and Municipal Libraries and Barangay Reading Centers throughout the Philippines, Appropriating the Necessary Fund therefore and for Other Purposes*"; R.A. 9246 or the "*The Philippine Librarianship Act of 2003*"; and R.A. 9470 otherwise known as the "*National Archives of the Philippines Act of 2007*," including their Implementing Rules and Regulations insofar as applicable, shall be considered supplementary to this Ordinance.

SECTION 9. SEPARABILITY CLAUSE. If, any provision in this Ordinance shall be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby. And if for any reason, any section of this Ordinance is declared to be unconstitutional or invalid the validity of the other provision shall not be affected and shall continue to be in full force and effect.

SECTION 10. REPEALING CLAUSE. Any ordinance or part thereof inconsistent herewith are deemed repealed or modified accordingly.

SECTION 11. EFFECTIVITY CLAUSE. This Ordinance shall take effect after the approval from the reviewing authority.
