MUNICIPAL ORDINANCE NO. 2025-006

**AN ORDINANCE DESIGNATING PARKING AREAS FOR MOTOR VEHICLES
AND MOTORCYCLES WITHIN THE POBLACION AREAS OF THE MUNICIPALITY
OF PIÑAN, ZAMBOANGA DEL NORTE AND PROVIDING FEES THEREOF AND
FOR OTHER PURPOSES**

Sponsored by: Honorable Divine Grace C. Redillas

Be it enacted by the Sangguniang Bayan of Pinan, Zamboanga del Norte in a session duly assembled that:

SECTION 1. TITLE– This Municipal Ordinance shall be entitled an “*An Ordinance Designating Parking Areas for Motor Vehicles and Motorcycles within the Poblacion Areas of the Municipality of Piñan, Zamboanga del Norte and Providing Fees Thereof and for Other Purposes*”.

SECTION 2. SCOPE AND OBJECTIVES. This ordinance supplements the existing traffic ordinances of this municipality. This is applicable to all motor vehicle and motorcycle owners and drivers within the territorial jurisdiction of this municipality. It aims to regulate and designate specific parking areas for motor vehicles and motorcycles within

the Poblacion areas of the Municipality of Piñan, Zamboanga del Norte. The ordinance will cover the establishment, management, and enforcement of designated parking spaces, as well as the implementation of parking fees within the identified areas with a focus on promoting public order, traffic management, and ease of access to essential services.

It has the objectives of regulating the parking of motor vehicles and motorcycles, promote better traffic flow and reduce congestion, ensuring the availability of parking spaces for residents and visitors, generating revenue, enhancing public safety and order, implementing an equitable and transparent fee system and support the development of the Municipality of Piñan.

SECTION 3. PARKING AREAS- the following are the spaces determined as parking areas:

- A. *For motorcycles (single/habal-habal), the parking area is in front of Laput Botika along Quirino Street.*
- B. *For three-wheeled vehicles (bao-bao), the parking area is in front of Mutia Store along Quirino Street.*
- C. *For private motorcycles and 4-wheeled vehicles, the parking areas will be the following:*
 - 1) *Areas in front J&T Warehouse, Chonlly Pem Pem Store, and Cebuana Padala and Pawnshop along Magsaysay Street.;*
 - 2) *Areas in front of Sugma Store and JCM Cellphone Repair Shop along Amaga Extension.;*
 - 3) *Areas in front of Carreon Residence and neighboring households along San Nicolas Street;*
 - 4) *Areas in front of SNRT Moto Shop, Misal Store, and Vallente Store; and*
 - 5) *Areas in front of Building 6 -Meat Shop*
- D. *For motorcycles, the parking areas will be the following:*
 - 1) *Areas between Building 3 and Building 2 Food Park; and*
 - 2) *Areas behind Bagsakan and Building 2 Food Park along Macapagal Street.*
- E. *For delivery vans, the parking area will be:*
 - 1) *Areas in front of PiMPCO*
- F) *Parking Extension areas will be:*
 - 1) *Areas in front of Icao Store, Mutia Store, and Gudmalin Store along Quirino Street.*

Provided however, that driveways along the authorized parking lane shall be maintained free of obstruction.

SECTION 4. LOSS AND DAMAGES ON PARKED MOTORCYCLES AND VEHICLES. The Municipal Government of Piñan shall not be held accountable for any loss of article(s) inside or outside a vehicle and/or damages thereof, regardless of amount or nature, while the vehicle is park at the parking area.

SECTION 5. PARKING TIME. The schedule of parking shall be as follows:

Monday to Sunday – 6:00 Am to 6:00 PM

SECTION 6. PARKING FEES. This parking fee covers the motorcycles or single motorcycles and motor vehicles as provided in this Ordinance.

•	Motorcycle/Single Motorcycle/Bao-Bao	P 5.00/every 4 hours
•	Motor Vehicle (<i>Private Cars and Service Vehicle</i>)	P 10.00/every 4 hours
•	Jeep/Panel/Delivery Trucks/Van	P 10.00/every 4 hours

SECTION 7. PARKING FEE ON REGULATED PARKING AREA. Parking Fees will only be applied on the following areas as enumerated under Section 3 of this Ordinance.

SECTION 8. EXEMPTION/DISCOUNT/ PRIVILEGE- The imposition of parking fee mandated by this ordinance and existing ordinances shall be subject to exemption/discount/privilege as set forth below:

- a.) Local Government Officials and Employees may avail of the parking space free of charge during working hours; and
- b.) Discount of 20% to Senior Citizens and PWDs.

SECTION 9. COLLECTION-IN-CHARGE. The Municipal Treasurer or his or her authorized representative is hereby empowered to collect herein parking fees using any form of official receipt he may devise from the conductor, driver, operator and/or owner of the motor vehicles parked in said designated parking areas and the motor shall be recorded on a separate subsidiary ledger. On the other hand, any designated personnel by the Local Chief Executive may be allowed to collect parking fees.

SECTION 10. PENAL PROVISION. Any person or persons, violating any provision of this ordinance shall be meted with the following:

- 1st Offense – Fine of Two Hundred Pesos (P 200.00);
- 2nd Offense – Fine of Three Hundred Pesos (P 300.00);
- 3rd and Succeeding Offenses- Fine of Six Hundred Pesos (P 600.00) or imprisonment of three (3) months or both at the discretion of the court.

SECTION 11. SEPARABILITY CLAUSE – If, for any reason, this Ordinance or parts hereof be declared unconstitutional or invalid by a competent court, other parts or provisions thereof not affected shall remain in full force and effect.

SECTION 12. REPEALING CLAUSE – All Ordinances, issuances, rules and regulations inconsistent with the provisions of this ordinances are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY CLAUSE – This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
