RESOLUTION AUTHORIZING HONORABLE CECILIA J. CARREON, MUNICIPAL MAYOR THIS MUNICIPALITY TO EXECUTE AND SIGN FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF PIÑAN, ZAMBOANGA DEL NORTE THE DEED OF DONATION IN FAVOR OF THE PHILIPPINE NATIONAL POLICE ON A PARCEL OF LOT KNOWN AS LOT-2-A, BLK 2 INVOLVING AN AREA OF SIX HUNDRED SQUARE METERS (600 SQ.M.) COVERED UNDER TCT NO. 127-2019000779 LOCATED AT POBLACION NORTH, THIS MUNICIPALITY FOR THE PNP BUILDING SITE

WHEREAS, the Local Government Unit of Piñan generously imparts a portion of its owned lot for use in the Philippine National Police as their building site;

WHEREAS, Lot 2-A, Blk 2 containing an area of Six Hundred Square Meters (600 sq.m.) covered under TCT No. 127 -2019000779 located at Poblacion North, has to be transferred and conveyed to the donor through Deed of Donation;

WHEREAS, in giving effect on this deed, this Honorable Body hereby granted an authority to execute and sign for and on behalf of the Local Government Unit of Piñan the Deed of Donation;

WHEREAS, the Donor hereby conveys the above-described property to the Donee, its successors and assigns, including all improvements thereon free from liens and encumbrances and the same be accepted by the donee;

WHEREFORE, based on the foregoing;

RESOLVED, as it is hereby **RESOLVED**, to authorize Honorable Cecilia J. Carreon, Municipal Mayor this Municipality to execute and sign for and in behalf of the Local Government Unit of Piñan, Zamboanga del Norte the Deed of Donation in favor of the Philippine National Police on a parcel of lot known as Lot-2-A, Blk 2 involving an area of Six Hundred Square Meters (600 sq.m) covered under TCT No. 127-2019000779 located at Poblacion North, this municipality for the PNP Building Site.

RESOLVED FURTHER, to furnish copy of this Resolution to Honorable Cecilia J. Carreon, Municipal Mayor, LGU, Piñan, Zamboanga del Norte and PBGen Franco P. Simborio, PRO 9 Regional Director, Police Regional Office 9, Mercedes, Zamboanga City, for proper information and appropriate action.
