RESOLUTION NO. 2022-145

**RESOLUTION APPROVING THE CONSTRUCTION OF STALLS FOR *TUBA*
VENDORS IN THE PUBLIC MARKET OF PIÑAN, ZAMBOANGA DEL NORTE**

WHEREAS, during the regular session on July 25, 2022, Hon. Belangoy, on his privileged speech, raised the issue on the situation of the *tuba* vendors in the municipal public market;

WHEREAS, the *tuba* vendors have no permanent area in the market where they could sell their products;

WHEREAS, they were always directed to move from one spot to another, and that they only have makeshift stalls which cannot protect them from direct heat from the sun and from getting wet from the rain;

WHEREAS, Honorable Belangoy asserted that the LGU should not neglect these micro business owners, and that the LGU should protect them by giving them comfortable stalls, and by providing them decent and permanent area to do their business;

WHEREAS, as the Chairman of the Committee on Market and Slaughterhouse, Honorable Ricardo R. Sabandal made an ocular inspection, and confirmed to the Honorable Council on August 8, 2022 regular session of the need of the construction of stalls for *tuba* vendors in the municipality's public market;

WHEREAS, Honorable Sabandal coordinated with the Municipal Engineer, Engr. Eugene Del Niño D. Mayon, and the latter mentioned that he already prepared a Program of Works (POW) for the proposed construction of stall;

WHEREAS, this Honorable Body finds it imperative for the Local Government Unit of Piñan to prioritize this matter and to give it prompt consideration;

NOW THEREFORE, on motion of Honorable Ricardo R. Sabandal, duly seconded by Honorable Enrique P. Acoymo, it was;

RESOLVED, as it is hereby **RESOLVED**, to approve the construction of stalls for *tuba* vendors in the public market of Piñan, Zamboanga del Norte.
