RESOLUTION NO. 2017-005

RESOLUTION REQUESTING PRESIDENT RODRIGO ROA DUTERTE, PRESIDENT REPUBLIC OF THE PHILIPPINES THROUGH CABINET SECRETARY LEONCIO B. EVASCO, JR., TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF DRUG REHABILITATION CENTER IN THE MUNICIPALITY OF PIÑAN, PROVINCE OF ZAMBOANGA DEL NORTE

WHEREAS, it has been the mandate of the Constitution that the government shall promote the quality of life of the people and Section 16 of the Local Government Code of 1991 provides that local government units shall pursue undertakings to improve public morals and maintain peace and order;

WHEREAS, the new administration aims to suppress or even eradicate rampant use of illegal drugs in the country that significantly contributed to multiple crime incidents;

WHEREAS, the Municipality of Piñan is in full force in supporting the anti-drug campaign of the present administration and fortunately, many of the drug victims voluntarily surrendered and made a commitment to the Local PNP not to commit any more crimes;

WHEREAS, the Local Government Unit of Piñan is willing to assist or enhance the anti-drug campaign by giving priority to the drug victims through establishment of Rehabilitation Center as the support institution;

WHEREAS, considering that Piñan is a fourth class municipality and depends on the support given by the National Government, hence, allocation for the construction of the Drug Rehabilitation Center could hardly be realized;

WHEREAS, knowing on the gratuitous deed and benevolence of the President of the republic of the Philippines that focus mainly to the welfare of the constituents, this Honorable Body intended to ask your assistance and support for the allocation of funds in the construction of Drug Rehabilitation Center in this municipality;

WHEREFORE, on motion of Honorable Loreto C. Bagatua, duly seconded by Hon. Alfred E. Palconayo, it was;

RESOLVED, AS IT IS HEREBY RESOLVED, to request President Rodrigo Roa Duterte, President of the Republic of the Philippines through Cabinet Secretary Leoncio B. Evasco, Jr., to allocate funds for the construction of Drug Rehabilitation Center in the Municipality of Piñan, Province of Zamboanga del Norte.

RESOLVED FURTHER, to furnish copy of this enactment to President Rodrigo Roa Duterte, President of the Republic of the Philippines, Office of the President Malacanan Palace Compound, J.P. Laurel, St., San Miguel, Manila and Secretary Leoncio B. Evasco, Jr., Office of the Cabinet Secretary, Malacanan Palace, Manila, for their proper information and appropriate action.
