**DECLARING *OPERATIVE*, BARANGAY APPROPRIATION  
ORDINANCE NO. 01, SERIES OF 2016 OF BARANGAY SIKITAN, PIÑAN,  
ZAMBOANGA DEL NORTE**

On motion of Hon. Greg C. Belangoy, duly seconded by Hon. Saturnino P. Sorronda, it was;

**RESOLVED**, as it is hereby **RESOLVED**, that the recommendation of the Body's Committee on Finance, Budget and Appropriation on Barangay Appropriation Ordinance No. 01, Series of 2016 entitled "*An Appropriation Ordinance Authorizing Fiscal Year 2016 Annual Budget of Barangay Sikitan, Piñan, Zamboanga del Norte in the amount of One Million Two Hundred Twelve Thousand One Hundred Forty Pesos ( P 1, 212, 140.00) per Committee Report No. 02, Series of 2017 dated January 9, 2017, be declared *operative*, subject to compliance on the following conditions, viz:*

1) *The 20% Development Fund shall be utilized for program/projects and activities identified by the Barangay Development Council in a duly approved Annual Investment Plan consistent with the guidelines prescribed by Joint DBM & DILG Memorandum Circular No. 2011-1 dated April 13, 2011;*

2) *The 5% LDRMC fund shall be used to support pre-disaster preparedness programs and post -disaster activities consistent with the guidelines prescribed under par. 3.0 of COA Circular No. 2012-002 dated September 12, 2012;*

3) *The Annual Budget shall include programs, projects/ activities that can be attributed and built in within the budget level for the following:*

- a) Gender and Development (GAD) pursuant to RA No. 7192;*
- b) Senior Citizens and Persons with Disabilities pursuant to RA 9242;*
- c) Acquired Immune Deficiency Syndrome (AIDS) pursuant to RA No. 8504; and*
- d) Implementation of the Programs of the Local Councils for the Protection of Children (LCP) pursuant to RA 9344.*

**RESOLVED FURTHER**, that actual disbursement of funds authorized in the foregoing enactment shall be subject to pertinent budgeting, accounting and auditing laws, rules and regulations.

**RESOLVED FURTHERMORE**, that the implementation of the annual budget shall be the sole responsibility of the barangay officials concerned.

**RESOLVED FINALLY**, to furnish copy of this enactment to Hon. Cecilia J. Carreon, Municipal Mayor; Ms. Asuncion N. Saludsod, Municipal Budget Officer; Atty. Elma L. Awit, CPA, Municipal Accountant; and the Sangguniang Barangay Council of Sikitan, Piñan, Zamboanga del Norte through Hon. Violito B. Luague, Punong Barangay, for information and reference.
