RESOLUTION NO. 2017-001

**EXTENSION OF TIME PAYMENT OF ALL LOCAL TAXES OR
CHARGES WITHOUT SURCHARGES OR PENALTIES FROM JANUARY 21 -
31, 2017 IN THIS MUNICIPALITY**

WHEREAS, Section 167 of the Local Government Code of 1991 provides the time of payment of all local taxes, fees or charges which shall be within the first twenty (20) days of January of each subsequent quarter, as the case may be;

WHEREAS, it was also provided that extension of payments maybe granted in accordance to the Sanggunian Bayan power and authority as long as it has justifiable or meritorious reasons, of which the payment shall not exceed on the six (6) months period;

WHEREAS, finding the economic crisis and unstable business operations suffered by businessmen and taxpayers in this municipality, the payment of taxes, fees or charges on time could hardly be done;

WHEREAS, hearing the sentiments and observing the unsecured pecuniary condition of the taxpayers, this Council finds it meritorious to give credit and ample consideration by extending the term of payment from the scheduled date as provided in RA 7160;

NOW THEREFORE, on motion of Honorable Glecerio Y. Redillas, Jr., deemed seconded by Honorable Saturnino P. Sorronda; it was;

RESOLVED, AS IT IS HEREBY RESOLVED, to extend the time payment of all local taxes, fees or charges without surcharges or penalties from January 21 -31, 2017 in this municipality;

RESOLVED FURTHER, to request Honorable Cecilia J. Carreon, Municipal Mayor through the Municipal Treasurer for the implementation of this extension of the payment period as provided on the above-mentioned dates.

RESOLVED FURTHERMORE, to furnish copy of this resolution to Honorable Cecilia J. Carreon, Municipal Mayor and Ms. Syldia A. Bagatua, Municipal Treasurer, all of LGU, Piñan, Zamboanga del Norte, for proper information and appropriate action.
