**RESOLUTION AUTHORIZING HON. CECILIA JALOSJOS-CARREON, MUNICIPAL MAYOR IN BEHALF OF THE RURAL HEALTH UNIT UNDER THE LOCAL GOVERNMENT UNIT OF PINAN, ZAMBOANGA DEL NORTE TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE ZAMBOANGA DEL NORTE MEDICAL CENTER REPRESENTED BY HONORABLE ROBERTO Y. UY, PROVINCIAL GOVERNOR, PROVINCE OF ZAMBOANGA DEL NORTE FOR THE REFERRAL AGREEMENT ON MATERNITY CARE SERVICES**

**WHEREAS**, Maternity Care Services provides quality care to the maternal mothers who are expecting births and prevent maternal complications that may arise on the expectant mothers;

**WHEREAS**, to ensure that quality care is provided to the patient, the Service Provider is required to tie up with the referral hospital that provides adequate medical instruments needed for the management or obstetric or newborn complications;

**WHEREAS**, a Memorandum of Agreement is necessary to stipulate therein the terms and conditions which both parties must have to consider and agreed upon;

**WHEREAS**, provided on the agreement the necessity and importance of functions of the service provider and referral hospital for the safety, protection and welfare of the mother and the newborn;

**WHEREAS**, the engagement of services by the Rural Health Unit of Piñan to Zamboanga del Norte Medical Center for complicated maternal cases has already been practiced, however, there is a need to update the referral agreement corresponding to the persons being authorized to represent the same ;

**NOW THEREFORE**, on motion of Honorable Rommel I. Gudmalin, deemed seconded by Honorable Saturnino P. Sorronda; it was;

**RESOLVED, AS IT IS HEREBY RESOLVED**, to authorize Hon. Cecilia Jalosjos-Carreon, Municipal Mayor in behalf of the Rural Health Unit under the Local Government Unit of Pinan, Zamboanga del Norte to enter into and sign a Memorandum of Agreement between the Zamboanga del Norte Medical Center represented by Honorable Roberto Y. Uy, Provincial Governor, Province of Zamboanga del Norte for the referral agreement on Maternity Care Services.

**RESOLVED FURTHER**, to furnish copy of this resolution to Honorable Cecilia J. Carreon, Municipal Mayor, LGU, Piñan, Zamboanga del Norte, and Hon. Roberto Y. Uy, Provincial Governor, Province of Zamboanga del Norte, ZN Convention Center, Dipolog City, for proper information and appropriate action.
