REQUESTING PRESIDENT RODRIGO ROA DUTERTE, PRESIDENT REPUBLIC OF THE PHILIPPINES THROUGH CABINET SECRETARY LEONCIO B. EVASCO, JR., TO ALLOCATE FUNDS TO BE USED IN THE CONSTRUCTION OF LIVELIHOOD AND TRAINING CENTER IN THE MUNICIPALITY OF PIÑAN, PROVINCE OF ZAMBOANGA DEL NORTE

WHEREAS, the Local Government Unit of Piñan implemented and offered scholarship programs in coordination to the Technical Education and Skills Development Authority (TESDA) to encourage full participation and mobilize industry in the skills development of the human resource;

WHEREAS, various offered programs and skill trainings were already conducted in this municipality participated by the out-of-school youths, unemployed men and women, and other NGOs to help them in the upliftment of their way of living;

WHEREAS, it is the aspiration of this Council to possess a livelihood and training center to continue the skills learning and apply their learned skills towards the real world of work;

WHEREAS, much to the desire to construct a livelihood and training center, the same could hardly be realized due to insufficiency of funds, and the allotment given by the National Government through IRA is commensurate to the basic needs and services of the LGU as identified and prioritized by the planning Council;
